Bentonville, Arkansas, April 21, 2009 – WellQuest Medical & Wellness Corporation (“WellQuest”) (OTCBB:WEQL), announced that it has received approval from the Financial Industry Regulatory Authority for trading on the OTC Bulletin Board under the ticker WEQL.

WellQuest reported revenues of \$3.3 million for the fiscal year ended December 31, 2008, a 39% increase over revenues of \$2.4 million in fiscal 2007.
